Minutes of a **Planning & Environment Committee meeting** held at 7.00 pm on Tuesday, 29th April 2025 at the Guildhall, Much Wenlock

1. Apologies

2. Disclosure of Pecuniary Interests

8. Much Wenlock Neighbourhood Plan

Members reviewed preparations for forwarding the Submission Version of the Draft Much Wenlock Neighbourhood Plan 2024 to 2028 to Shropshire Council following its approval by full Council on 3rd April 2025. Minor corrections were being submitted to the Council's consultant and the Plan would be submitted as soon as the amendments had been made.

At the Chairman's discretion, agenda item 13 was brought forward.

9. Climate Change and Ecological/Nature Emergencies*

Members noted concerns from members of the public regarding the possible development of a solar farm at Bourton. It was RESOLVED to send a letter to Mr Mickelthwait of Bourton Estates to enquire about his intentions with regard to a potential solar farm at Bourton.

10. Telford & Wrekin Local Plan Review

- a. Members noted that the publication version of the Telford & Wrekin Local Plan Review (2020-2040), the final public review stage, was available for public comments until 4pm on Monday 5th May 2025.
- b. The Transport Working Group had no comments on the proposals of the above in relation to Much Wenlock.

Members noted that there had been no response from Marrons to correspondence from the Clerk.

12. Flooding Matters

- a. Members noted the update from Shropshire Council's Drainage and Flood Risk Manager on progress with the DfT flood attenuation project on the Bourton Road.
- b. Members considered the Reservoir Safety Report on Shadwell Quarry prepared by Mott MacDonald on behalf of the Environment Agency. The Much Wenlock Flood Action Group had expressed concerns about the conclusions of the report. Councillors agreed that the water level in the quarry was rising and this had been seen clearly since the Covid lockdown. There were local concerns about the stability of made-up ground around the quarry but the report stated there were no indications that the water body was raised above the level of the surrounding natural ground.

To date, the Town Council had raised concerns about potential risk from the quarry with the Environment Agency, Shropshire Council and the Health & Safety Executive.

The Clerk was asked to request that the Council's archivist search for records or photos showing the development of the quarry, previous water levels, use, access, etc. Councillors agreed to await the outcome of the Flood Action Group's discussions before considering whether to make any response about the report to the Environment Agency.

c. Other flooding matters: the incorrectly fitted manhole cover in the High Street had now been replaced as required.
