## Good Afternoon Trudie,

Re the email trail below, whether the location is within a Conservation Area or not does not generally have a bearing on whether Advertisement Consent is required for signage. However, the regulations are worded such that the triggers for requiring Advertisement Consent would also protect the Conservation Area e.g. if a shop sign is proposed to be illuminated (other than to indicate medical services) it requires Advertisement Consent, and if it is within a Conservation Area it would be unlikely that such an application would be supported by officers – illuminated signs in Conservation Areas are strongly resisted. Additionally, it would be expected that any signage proposed through an Advertisement Consent Application in a Conservation Area would be of high quality and consist of appropriate traditional materials.

There is some signage such as advertisements on hoardings around temporary construction sites that do require Advertisement Consent if the site is within a Conservation Area.
